

This shower enclosure shall be Accessibility Professionals Model APTS4136BF875
The unit shall be molded from a single sheet of acrylic so as not to have any seams or joints. It shall meet ANSI A117.1 and ANSI 124.2, shall have the backside fire rating of 'A' and a flame spread of less than 25, shall be designed to meet ADA, FHA, HUD, BOCA, NAHB, UPC and shall meet the requirements of most state and national standards on design for the disabled including Southern Building Code. The unit shall have inside dimensions of 36' x 36' x 80 1/2' and the outside dimensions of 41 1/4' x 36 1/4' x 82 7/8'.

The enclosure may be equipped with the following factoy installed accessories: 1) one 17 1/2'x 32 1/2'x 1 1/2' diameter stainless steel, L-shape grab bar with 1 1/2' clearance statute, mounted with stainless steel bolts secured from the rear with 3' x 3', 11 guage metal backing plates, 2) 1' diameter 20 gauge stainless steel curtain rod, 3) self caulking brass drain with chrome strainer, 4) HDPE plastic fold up seat. 5) 7/8' threshold for easy base, 6) wood for future grab bar on valve wall.

Warranty: 3 years when installed in accordance with manufacturers installation

Code Reference Listing: This model shall meet or exceed the following code listings when fully accesorized and installed according to each codes requirements: ANSI124.2, HUD, BOCA, NAHB, UPC, the Southern Building Code, ADA, & ANSI 117.1. Installation Requirements: A 10° core drill or molded voids in slab/sub-floor surface a 1/2° deep are required to accept a natural drain slope of unit. A non-shrinking thin set bedding slurry is required for standard installation. Caulk all seams wisilicone. See Installation Instruction packet for further details.



Required: This option substantially reduces the degree of difficulty & labor usually to mudset a barrier free shower. Reduce the risk of inconsistant installations resulting in poor damage or soft floors. Downsize from full base mudset to a 10' area encompassing the drain. Alt. Installation Instructions Required see packet for details.

NOTE: EACH SIDE WALL CONTAINS A FEATURE LINE FROM 30" TO 32" HORIZONTAL THIS FEATURE LINE OFFSETS 3/8" FROM THE SIDE WALL. IN PLUMBING PLANS ENSURE THIS WILL NOT INTERFERE WITH VALVE AND PLUMBING PLACEMENT.
